Overview

Deborah has a special interest in historic abuse claims, including abuse in care establishments, foster care, individual assault claims and social care negligence. In the last twenty years she has acted for Claimants in numerous group actions, with and without leading counsel.

As a personal injury practitioner of many years, she has either pursued or been required to meet numerous allegations of fraud and exaggeration.

Deborah has extensive experience of issues relating to limitation, representing Claimants at preliminary hearings in historic abuse claims.

She undertakes a range of cases, including negligent treatment, misdiagnosis, dental negligence and general surgery.
