## Overview

# Expertise

## Personal Injury

Louise maintains a busy court diary of trials and interim applications and accepts instructions across all tracks on behalf of both claimants and defendants. She acts in all personal injury claims, including employer's liability, public liability, highways, road traffic accident and animal claims, and also has experience in personal injury claims arising out of public and private nuisance.

## Serious Injury

Louise is regularly instructed on high value cases involving fatal accidents, traumatic brain injury, amputations, facial disfigurement and other serious injuries. She has experience of handling claims for provisional damages and preparing schedules into the six figures involving significant claims for future losses.

## Clinical Negligence

Louise is available to instruct on all clinical negligence matters, and acts in medical, dental and pharmaceutical negligence claims.

Louise also has a sub-speciality in negligently performed cosmetic, aesthetic and beauty treatments and can be instructed on all matters including claims involving Botox, fillers, microneedling, semi-permanent make up, laser hair removal and more.

## Inquests

## Animals & Equine

She can also be instructed in contract disputes concerning the purchase and sale of animals, unpaid livery fees, training of dogs and horses, injury to animals, and more. Louise is also experienced in police law and is well-placed to be instructed on matters concerning police dogs and horses.

## Police Law

Louise has experience in claims involving unlawful arrest, false imprisonment, use of force, personal injury, and aggravated and exemplary damages. Having previously practiced criminal law, she is well-versed in PACE 1984. She also has comprehensive knowledge of the Animals Act 1971 and can be instructed in relation to matters concerning police dogs and horses.

Louise has acted in judicial review proceedings in the High Court concerning police investigations, as well as in contested applications for confiscation orders, sexual harm prevention orders, stalking prevention orders and domestic violence protection orders. She also has experience handling police disclosure including public interest immunity applications.

Having also previously practiced family law, Louise is well-placed to act in matters where there is an interplay between the civil, criminal and family jurisdictions.

## Abuse

Louise has previously practiced in criminal and family law and has experience handling cases involving sexual, physical, emotional and financial abuse and domestic violence. She is available to instruct on matters involving abuse and understands that these claims involve careful and empathetic management, with meticulous attention-to-detail.

## Disease
